

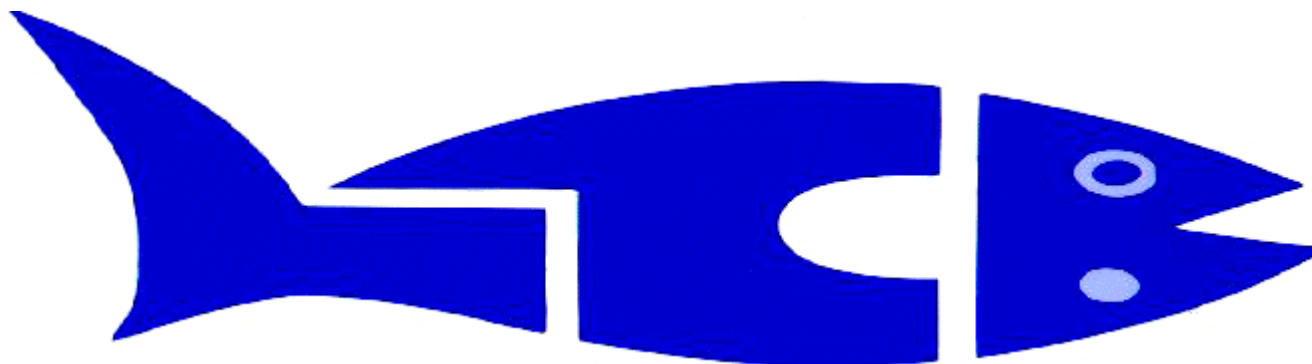

- RULES:** Current USA Swimming and Indiana Swimming rules will govern this meet. USA Swimming rules 202.3.2-At a sanctioned competitive event, USA Swimming athlete members must be under supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The meet director or Meet Referee shall assist the athlete in the making arrangements of such supervision.
- “Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement.”
- In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.10.11. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee
- Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, restrooms or locker rooms.
- START:** No recall start procedure will be used.
- FORMAT:** Friday’s events will all be timed finals. Saturday and Sunday’s will be prelim/finals competition (championship based).
- ELIGIBILITY:** Held under the sanction of USA Swimming, Inc. **Sanction IN12030**. Current USA Swimming, Inc. registration required. No entries will be accepted unless the entrant is either registered or certified with USA Swimming, Inc. The swimmer's age as of February 24, 2012 will determine the age of the swimmer for the entire meet. Coaches **MUST** constantly display their USA Swimming coach credential to gain access to the deck. The meet referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply.
- CHECK IN/ SCRATCH:** This is a **positive sign-in meet**. Positive sign-in means, “I’m here, I intend to swim.” To sign in positively, highlight swimmer’s name on sign in sheets. Sign-in sheets will be posted before the start of warm-ups. The deadline for positive sign-in will be 30 minutes before the scheduled start of the session. At that deadline, the sheets will be removed and no changes or corrections will be accepted. Any swimmer scratched under this rule may present to the referee at least 2 minutes before the start of the slowest heat of the event(s) scratched and request to swim in an empty lane. The referee will honor such requests on a first come, first served basis and only to the extent empty lanes are available.
- SCRATCH RULE:** A swimmer qualifying for a consolation final or final race following preliminaries notifies the designated person within thirty (30) minutes after the announcement of the qualifiers for that finals race that the swimmer will not compete and further declares their final intentions within 30 minutes following the swimmers last individual preliminary event. Failure to scratch before the thirty (30) minute time limit and not swimming the event will result in the swimmer being barred **from all further competition that day and the first individual event the following day. There is no penalty for missing a timed final event or a preliminary heat of an event. Penalties shall only apply to the original 12 placed swimmers.**
- CLERK OF COURSE:** **NO CLERK OF COURSE.** Seeded heat sheets will be posted on deck immediately before the start of each session. It is the swimmers responsibility to appear at the correct starting platform ready to swim in time for the initial start of his/her heat. Only coaches, swimmers, officials & meet volunteers are allowed on deck. This is a requirement of USA Swimming.
- FACILITY:** 6-lane 25 yd competition pools with non-turbulent lane markers, Daktronics electronic timing equipment, spectator seating.
- The competition course has not been certified in accordance with 104.2.2C (4). Where a moveable bulkhead is used, course measurement of the lane in which the record was set (American, US

Open, or National Age Group Records) must be confirmed at the conclusion of the session during which the time was achieved.

The water depth at the starting end of the pool is 4'6".

**ENTRY LIMIT:**

Swimmers may swim a maximum of two (2) individual events on Friday and three (3) individual events and one (1) relay per day on Saturday and Sunday. Total number of swims will be limited to ensure a timely completion of the day's events. All entries will be accepted in the order received to the maximum number or the 4 hour time rule. (Clubs will not be split) Host club reserves the right to fill events with their own swimmers.

**FEES:**

EACH INDIVIDUAL EVENT: **\$2.50 Timed Final/\$3.00 Prelim/Final**

EACH RELAY: **\$5.00**

INDIANA SWIMMING SURCHARGE: **\$1.50** per swimmer

**ENTRY FORMS:**

Entries will be accepted starting Monday, January 27, 2012. The entry deadline will be 5 pm on Friday February 10, 2012. We will extend the deadline if the meet is not full. All entries must also be listed by name, age, and USS number. The summary of entries release form must be completed. Also include coach's proof of registration. All entry packets must be submitted via email (preferred method), US Mail or other delivery service. No hand deliveries or telephone entries will be accepted. Email entries should be sent to Jeff Kilinski at: [jeffsue\\_kilinski@sbcglobal.net](mailto:jeffsue_kilinski@sbcglobal.net) and will receive a return email confirmation. Please note that this confirmation only acknowledges receipt of the file, not acceptance into the meet. The email entry must be followed up by a hard copy of the entry information and submission of the hard copy prior to the entry deadline date.

**SCORING:**

Scoring and results by "HY-TEK" meet manager for Windows.

**AWARDS:**

Individual events will be awarded 1<sup>st</sup> – 12<sup>th</sup> place.  
Relay events will be awarded 1<sup>st</sup> – 3<sup>rd</sup> place.

**COACHES:**

Coaches packets will be available for the teams represented by three or more swimmers. Coaches meeting will be 15 minutes prior to each session. Coaches MUST constantly display their USA Swimming coach credential to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply.

**PLEASE NOTE:**      All events marked “\*” will be timed finals.

It is mandatory that all 1650 swimmers supply **1 timer (2 timers are preferred)**. Each 1650 swimmer has the option of supplying a lap counter or swimming without one. There will be a maximum of one (1) heat of girls and one (1) heat of boys in the 1650. The first six (6) entries in the girl’s event and the first six (6) entries in the boys will swim the 1650. Entries after the first six (6) will be alternates in the order received. Clubs will be notified if your swimmer is not in the top 6. Refunds will be given for those who do not qualify for the distance events.
